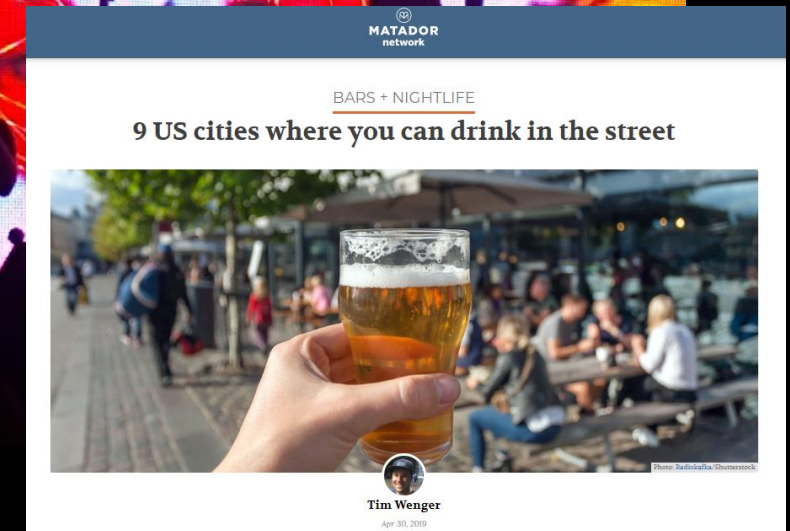
NIGHTLIFE IN EUROPE

- Nightclubs close between 3 – 8 am
- Specific venues offer after hour events
- Recent **increase of 24-hour permits**
- Mostly unlimited alcohol sales at clubs
- Smoking in clubs mostly prohibited
- Established coalitions



NIGHTLIFE IN THE U.S.

- Prohibition – Speakeasies
- Nightclubs close between 2 – 4 am
- After hour events are rare
- **No 24-hour permits**
- Last call (alcohol) at **2 am**
- Zero tolerance smoking in clubs
- Lack of established coalitions

METHOD & RECRUITMENT

- Data from the **Global Drug Survey 2018** were used to compare **alcohol and stimulant use** patterns among people who visited clubs in Berlin, Amsterdam, Zurich, California or New York at least monthly (**N=3,297**)
- Recruitment via social media, media partners, researchers, harm reduction organizations

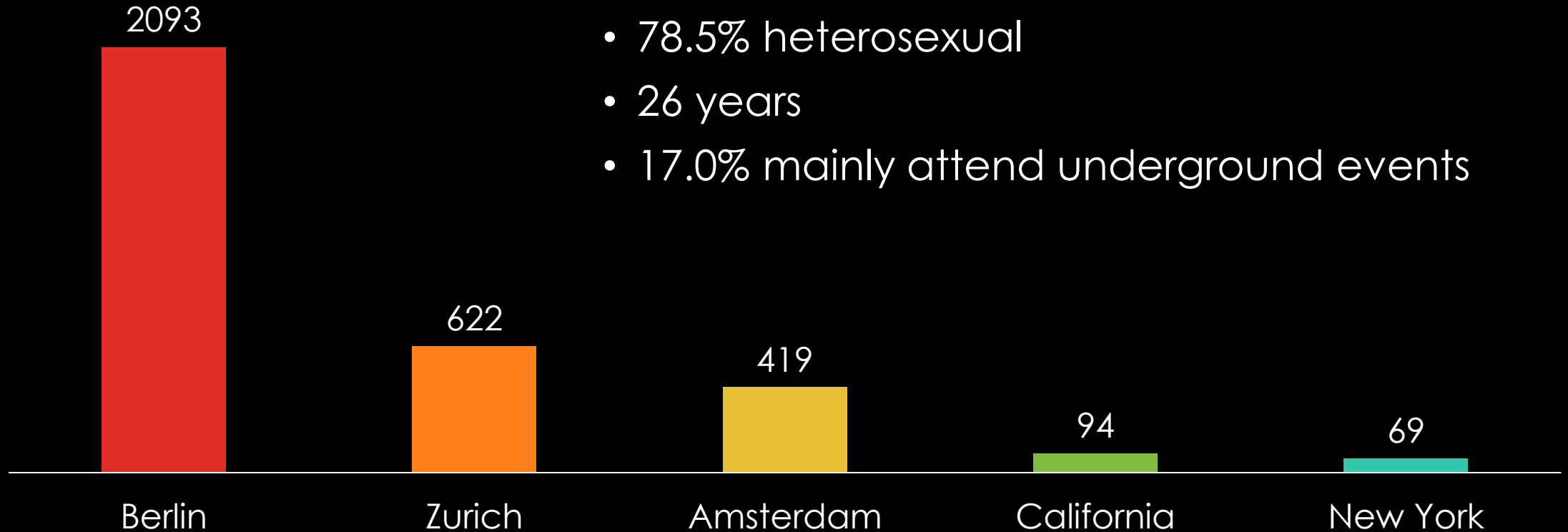

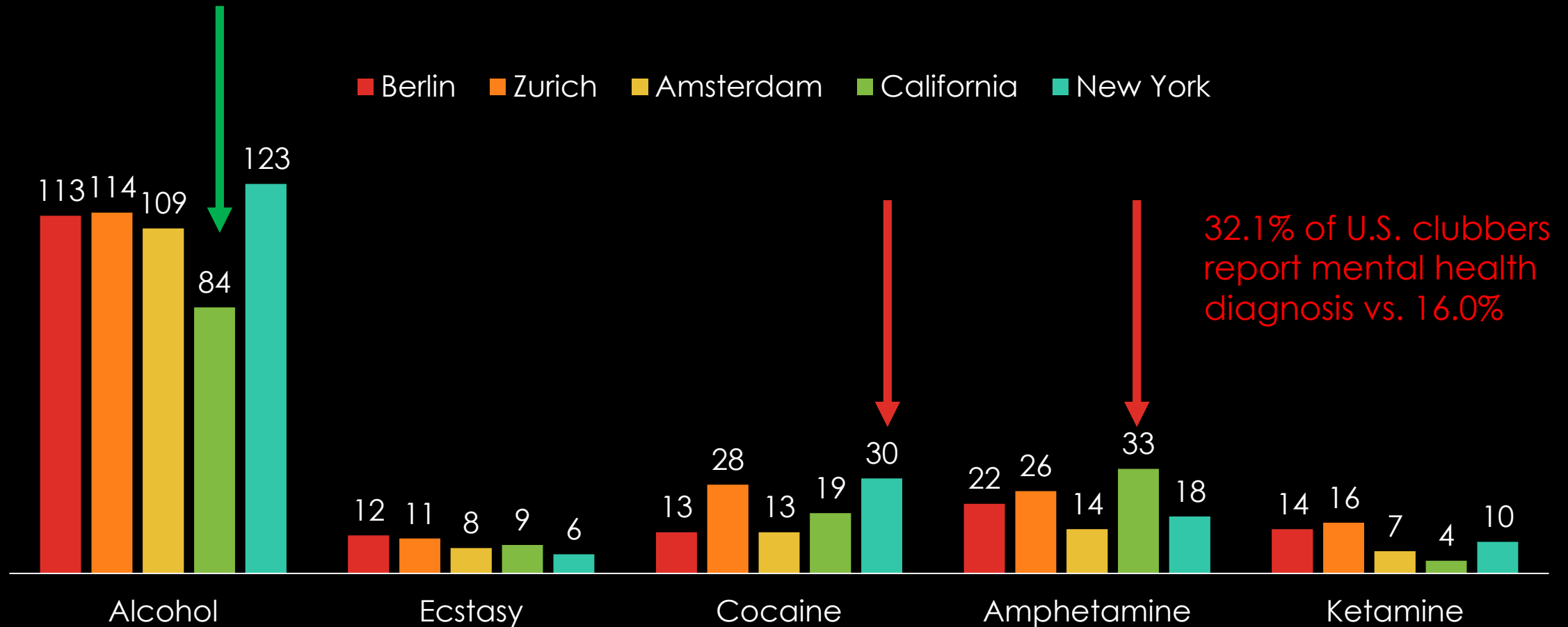
